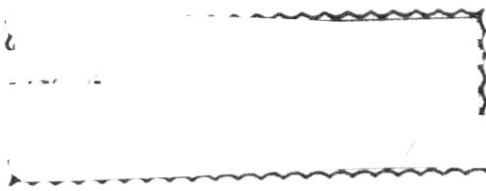
PERSONAL FINANCIAL STATEMENT AFFIDAVIT

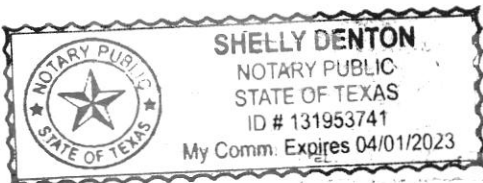
